10. What would you do to ensure that your constituents each have a truly equal and fair opportunity to succeed based on merit and effort, rather than pre-existing status or classification? I believe that the most important way of accomplishing this is through true government transparency and accountability. Also giving my constituents better access to government and information

11. What benefits and problems come from increasing population; how would you address them?

There are always great things that happen with growth. We have experienced growth over the last 10 years in Pierce County District #3 and with that have come an increase in property value and more money flowing into our local communities from consumers. But specifically, in this district the problem that has followed is that the infrastructure that is supposed to support this growth has not followed. Some of the things that I would like to consider to address these issues are, upgrading our street lights in the areas that have changed the most from rural to urban. Work on land use coding that would provide schools access to land where housing developments over a certain size are being built.

12. How would you support workers, including union workers, whether employed privately or by the government?

Better living wages and working conditions need to be provided for workers. The government should set the standard by example for employee protections if it is going to hold private organizations accountable to working standards.

13. What policies and actions would you take to protect and improve the natural environment?

We need to invest in more renewable energy sources in our region, and on the county level we can help do that through creating better standards for utilities.

- 14. What would you do to increase housing access and decrease income inequality? We have made great strides in Washington State to address the minimum wage, but this can not be a one and done fix. There needs to be a comprehensive schedule with minimum wage while recognizing and addressing the challenges of our small businesses.
- 15. Identify any budget challenges for your elected office/body; how would you deal with them? There is not enough money to properly deal with mental health. This is important because many of our men and women who are incarcerated would be serviced better with mental health serviced than steel bars. Many of our homeless population are dealing with serious mental health issues, that if addressed would place them in a stable mindset that would then prepare them for a stable environment.
- 16. How will you approach safety, police, and court system issues and what are they?

Public safety is the largest part of our budget. combined with our courts, they add up to well over 70% of our overall budget. We spend way too much to lock people up that don't need to be in jail. I will work to build better relations between communities and police and bring innovative legislation to reduce costs our courts and jails put on our county budget.
